

2026 Jr. SPORTS CLINIC

PLEASE NOTE: At this time, we do not anticipate construction of the new pool to be completed in time for this year's Jr. Sports Clinic. As such, we are only including Golf, Fishing and Tennis in this year's camp – **there is no plan to include a Swimming element this year.**

The schedule will remain the same: 9:00 am start time concluding at 1:00 pm, Monday through Friday beginning June 1st and wrapping up with the Awards Ceremony on June 12th.

We fully expect to return Swimming to the 2027 Jr. Sports Clinic.

JUNIOR SPORTS CLINIC – 2026 GUIDELINES

PURPOSE

The purpose of the Junior Sports Clinic is to provide children with diverse sports-related experience as they learn skills, discover new interests, make friends and build self-esteem. The children will receive instruction in tennis, golf and fishing. **NOTE – Due to ongoing pool construction at this time, we do not anticipate having a pool and therefore there is no plan to include a swimming segment of this year's Sports Clinic.**

PLACE

All the sports activities will be held in the area surrounding the Country Place Clubhouse.

TEAM

Country Place Chief Grounds Marshal Tonja Kachner will be the Director of the Junior Sports Clinic and will coordinate the sports activities with the lead instructors, their assistants and volunteers.

ELIGIBILITY*

Participation in the Junior Sports Clinic is open to resident children who have completed kindergarten and/or are entering first grade in the fall of 2026, through those entering the eighth grade. Participation will be extended to include relatives (i.e. cousins, nieces, nephews) and friends of residents.

**Enrollment of the youngest group will be limited. Contingent upon availability, a limited number of non-resident friends may also be eligible to enroll. Call the Country Place Office at 972-416-7825 for details.*

FOOD/WATER

This year we will not be providing snacks but will be providing bottled water. Please ensure that your child brings their own snacks labeled with their name.

DRESS

Children should dress in comfortable clothes and tennis shoes for general sports activities (please, no flip-flops). Children should also bring their own sunscreen each day. Having a labeled bag or backpack is a must!

COUNTRY PLACE I.D. TAGS

All participants must wear a current Country Place I.D. Tag. If your child does not have an ID Tag, please come to the office to have one made. If possible, come in the week before sports camp. The first morning of camp will be busy!

EQUIPMENT

Each child must have their own tennis racket. Golf clubs and fishing poles will be furnished, as well as tennis and golf balls.

DATES/TIME

The Junior Sports Clinic will be held Monday through Friday from 9 AM to 1 PM for two weeks beginning Monday, June 1st and ending Friday, June 12th. Promptness is appreciated and class starts at 9 AM.

DISCIPLINE

1st Infraction: Verbal Warning; 2nd Infraction: Written Warning with Director; 3rd Infraction: Child will be asked to leave for 2 days, then report to the Director for review prior to returning.

ENROLLMENT FEE AND PAYMENT TERMS

- SPACE IS LIMITED to ensure all enrollees receive instruction and have an enjoyable experience. Priority is given to resident families; friends are accepted when space is available.
- The early-bird discount enrollment fee of \$260.00 is available April 1 – April 30 per child for a 2-week enrollment.
- The early-bird discounted enrollment fee for one-week enrollment is \$150.00
- **ONE WEEK ENROLLMENTS ARE ONLY ACCEPTED FOR THE FIRST WEEK** (June 1-5).
- The regular enrollment fee (after April 30) is \$295.00 for 2-weeks and \$160.00 for 1-week.
- Full payment is due upon enrollment.
- Checks should be made payable to The Country Place, Inc.
- Enrollment forms and payment may be submitted to Tonja Kachner at the Pro Shop or to the Office.

CANCELLATIONS

All cancellations must be in writing.

- If the cancellation is made prior to May 25, the enrollment fee less a \$50 administrative fee will be refunded.
- If the cancellation is made on or after May 25, one-half the enrollment fee will be refunded.
- Beginning May 29, no refunds will be issued.

CANCELLATIONS DUE TO INCLEMENT WEATHER

If bad weather is in the area or forecast, an email will be sent to the parent's email to verify if that day's clinic will be held or cancelled. **PLEASE ENSURE YOU PROVIDE THIS EMAIL ADDRESS ON THE ENROLLMENT FORM.**

The Awards Ceremony will be held on the back patio of the clubhouse on **Friday, June 12th at 11:00 AM.** Family members are welcome to attend. Please RSVP the number in your party to attend by Wednesday June 10th to Tonja Kachner at 972-416-0660. Hot dogs, chips and cold drinks will be served.
